Our process to prevent slavery and human trafficking

Ensured staff have received a copy of our Slavery and Human Trafficking Statement for each applicable Financial Year, which requires staff to, amongst other things, uphold Evolve Energy's commitment to acting ethically and with integrity in all our business relationships and clearly states Evolve Energy's commitment to combating modern slavery and human trafficking.

2. Reviewed our policies and procedures, which require staff to, amongst other things, uphold Evolve Energy's commitment to acting ethically and with integrity in all our business relationships.

3. Established a Protected Disclosure Policy in accordance with the Public Interest Disclosure Act 1988 and outlined the procedure via our Intranet. This is to facilitate employees making any whistleblowing reports about organisations for which they work or provide services to which are deemed by law to be 'qualifying disclosures'.
